3. About GovCSIRT

3.1. All

GowaKab-CSIRT vision is the realization of cyber defense in the professional and reliable Gowa Regency Government.

3.2. Mission

The mission of GowaKab-CSIRT, namely:

- a. Creating Cybersecurity in gowa regency government
- b. building the capacity of cybersecurity incident countermeasures and recovery resources at the Gowa Regency Government

3.3. Constituents

GowaKab-CSIRT constituents include ICT user OPD in Gowa Regency Neighborhood

3.4. Authority

GowaKab-CSIRT has the authority to conduct incident management, incident mitigation, investigation and analysis impact of incidents, as well as post-security recovery on the Gowa Regency government.

GowaKab-CSIRT conducts countermeasures and recovery at the request of its constituents.

4. Policy - Policy

4.1. Types of Incidents and Levels/Level/ Support

CSIRT has the authority to deal with various cybersecurity incidents that occur or threaten our constituents (can be seen in Subbab 3.2).

Support provided by GowaKab-CSIRT to constituents may vary depending on the type and impact of the incident.

4.2. Cooperation, Interaction and Disclosure of Information/data

GowaKab-CSIRT will cooperate and share information with SulselProv-CSIRT, BSSN or other organization in the scope of cybersecurity.

All information received by GowaKab-CSIRT will be kept confidential.

4.3. Communication and Authentication

For regular communication GowaKab-CSIRT can use *e-mail* addresses without data encryption (conventional *e-mail*) and telephone. However, for communications that

contain sensitive/restricted/confidential information may use PGP encryption on *e-mails*.

5. Service

5.1. Main Service

GowaKab-CSIRT will help constituents to conduct countermeasures and recovery of cybersecurity incidents with the following aspects of cybersecurity incident management:

5.1.1. Cybersecurity-related warnings

This service is in the form of providing cyber threats and incidents to electronic system owners.

5.1.2. Countermeasures and Recovery of Cyber Incidents

This service is in the form of coordination, analysis, technical recommendations and on-site assistance in the framework of countermeasures and recovery of cyber incidents.

5.2. Additional Services

GowaKab-CSIRT actively builds the readiness of government agencies in countering and recovering cybersecurity incidents through:

- a. *Cyber Security Drill Test*
- b. *Workshop* or Technical Guidance
- c. CSIRT organization Formation Assistance
